**MISCELLANEOUS TERMS & CONDITIONS**

- a) **Meal Allowance**  
In the event that the Childminder is required to be in attendance for longer than 6 hours, the Childminder may order a meal to the value of \$30 through Room Service and at the cost of the Guest. In the event that Room Service is not available at the particular hotel, this amount will be added to the Childminding account and paid to the Childminder.
- b) **Leaving the Guests Room**  
Please indicate whether the Childminder has permission to take the child/children outside of the guest's hotel room. Unfortunately this cannot include any Resort swimming pools.
  - YES, children can be taken out of room
  - NO, children cannot be taken out of room
- c) **Emergencies**  
In the event of an emergency and where the Parent/Guardian is not reasonably contactable, the Guest consents to and directs the Childminder to contact the Duty Manager, doctor or the appropriate emergency service as the circumstances require. The Guest agrees to meet the expense associated with such actions and agrees to indemnify Voyages in that regard.
- d) **Charges**
  1. A rate of \$50 per hour or part thereof (inc. GST) applies seven days a week between the hours of service outlined below. There is a three (3) hour minimum charge (\$150). This charge will be added to the guests room account at the room nominated in this Agreement and will be payable on settling of the room account.
  2. A rate of \$70 per hour or part thereof (inc. GST) applies on Public Holidays.
- e) **Hours of Service**  
The Baby Sitting service operates 6am to 12am (midnight). Any extension of hours beyond 12am will be charged at \$70 per hour or part thereof.
- f) **Cancelations**  
At least 48 hours' notice is required to cancel the booking. If the booking is cancelled within 48 hours then a charge of \$150.00 applies.
- g) **Release & Indemnity**  
Whilst Voyages will exercise all reasonable care and skill in providing the childminding services, the guest for and on behalf of his or herself and the child or children involved, agrees to assume all risk and dangers associated with the provision of the childminding service and to the full extent permitted by law agrees to release, indemnify and hold Voyages harmless in relation to all liability, actions, claims and demands arising from or in connection with the provision of the childminding service. This includes without limitation, liability relating to death or personal injury, loss or damage to property, and all liability for indirect or consequential loss.
- h) **Warranty of Authority**  
The Guest signing this form warrants that they are the parent and or legal guardian of the relevant child or children and that they have full authority and legal right to arrange these childminding services with respect to the child or children.
- i) **Voyages may Refuse to Provide Service**  
Voyages provides childminding services as a community service to its Guest. On occasions, Voyages may, having regard to all circumstances, such as your child's special needs, medical conditions or a lack of suitable childminders may be unable to provide a childminder for you. Voyages expressly reserves the right to refuse in its absolute discretion to provide a Childminder in which case the Guest will have no recourse against Voyages.
- j) **Applicable Law**  
The terms of this agreement are governed by the laws of the Northern Territory of Australia.
- k) **Binding on other Parties**  
This Agreement is intended to be binding on the heirs and successors of the Guest and of the child/children involved.
